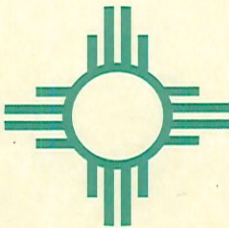
Declarations of intent to be a write-in candidate for state representatives, ~~two state senators~~, district judges, one district attorney, and public education commissioners shall be filed with the county clerk of the county in which the candidate resides, on Tuesday, March 15, 2022, between the hours of 9:00 a.m. and 5:00 p.m.

GENERAL ELECTION FILING DEADLINES:

~~Declarations of candidacy by pre-primary convention designation and nominating petitions~~ Declarations of candidacy and nominating petitions for independent and minor party candidates for the office of United States Representative, Governor, Lieutenant Governor, Secretary of State, Attorney General, State Auditor, State Treasurer, Commissioner of Public Lands, two justices of the Supreme Court, and two judges of the Court of Appeals, shall be filed with the Secretary of State on Thursday, June 30, 2022, between the hours of 9:00 a.m. and 5:00 p.m.

Declarations of candidacy and nominating petitions for independent and minor party candidates for state representatives, ~~two state senators~~, district judges, one district attorney, metropolitan court judges, magistrate judges, and public education commissioners, shall be filed with the county clerk of the county in which the candidate resides, on Thursday, June 30, 2022, between the hours of 9:00 a.m. and 5:00 p.m.

Declarations of candidacy and filing fees or, in lieu thereof, pauper statements for independent and minor party candidates for all other elective county offices shall be filed with the county clerk of the county in which the candidate resides on, Thursday, June 30, 2022, between the hours of 9:00 a.m. and 5:00 p.m.
